**A BILL**

To promote wildland firefighter safety.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Wildland Firefighter  
5 Safety Act of 2007”.

6 **SEC. 2. WILDLAND FIREFIGHTER SAFETY.**

7 (a) DEFINITIONS.—In this section:

8 (1) SECRETARIES.—The term “Secretaries”  
9 means—

10 (A) the Secretary of the Interior, acting  
11 through the Directors of the Bureau of Land  
12 Management, the United States Fish and Wild-

1 life Service, the National Park Service, and the  
2 Bureau of Indian Affairs; and

3 (B) the Secretary of Agriculture, acting  
4 through the Chief of the Forest Service.

5 (2) WILDLAND FIREFIGHTER.—The term  
6 “wildland firefighter” means any person who partici-  
7 pates in wildland firefighting activities—

8 (A) under the direction of either of the  
9 Secretaries; or

10 (B) under a contract or compact with a  
11 federally recognized Indian tribe.

12 (b) ANNUAL REPORT TO CONGRESS.—

13 (1) IN GENERAL.—The Secretaries shall jointly  
14 submit to Congress an annual report on the wildland  
15 firefighter safety practices of the Secretaries, includ-  
16 ing training programs and activities for wildland fire  
17 suppression, prescribed burning, and wildland fire  
18 use, during the preceding calendar year.

19 (2) TIMELINE.—Each report under paragraph  
20 (1) shall—

21 (A) be submitted by not later than March  
22 of the year following the calendar year covered  
23 by the report; and

24 (B) include—

1 (i) a description of, and any changes  
2 to, wildland firefighter safety practices, in-  
3 cluding training programs and activities  
4 for wildland fire suppression, prescribed  
5 burning, and wildland fire use;

6 (ii) statistics and trend analyses;

7 (iii) an estimate of the amount of  
8 Federal funds expended by the Secretaries  
9 on wildland firefighter safety practices, in-  
10 cluding training programs and activities  
11 for wildland fire suppression, prescribed  
12 burning, and wildland fire use;

13 (iv) progress made in implementing  
14 recommendations from the Inspector Gen-  
15 eral, the Government Accountability Office,  
16 the Occupational Safety and Health Ad-  
17 ministration, or an agency report relating  
18 to a wildland firefighting fatality issued  
19 during the preceding 10 years; and

20 (v) a description of—

21 (I) the provisions relating to  
22 wildland firefighter safety practices in  
23 any Federal contract or other agree-  
24 ment governing the provision of

1 wildland firefighters by a non-Federal  
2 entity;

3 (II) a summary of any actions  
4 taken by the Secretaries to ensure  
5 that the provisions relating to safety  
6 practices, including training, are com-  
7 plied with by the non-Federal entity;  
8 and

9 (III) the results of those actions.
